

ORDER

Whereas, Dr. Soma Gupta, Lecturer/Assistant Professor, DTU, Govt. of NCT of Delhi, was charge sheeted by Hon'ble Lt. Governor, Delhi, being competent disciplinary authority, under Rule 14 of CCS (CCA) Rules, 1965 vide charge memorandum No.F.5/DOVTTE/5/4/2014/5980 dated 11.06.2015, on the following articles of charge :-

That the said Dr.Soma Gupta, while functioning as Lecturer/Assistant Professor in the Department of Mathematics in Delhi Technological University, committed grave misconduct in as much as she remained absent from duty unauthoroizedly during the period w.e.f.13.01.2006 to 06.08.2006, 20.12.2006 to 10.01.2010 and 02.08.2010 till date, adversely affecting the studies of her students in the University.

By the above acts of omission & commission, the aforesaid Dr. Soma Gupta, Lecturer/Assistant Professor exhibited lack of integrity and devotion to duty, which is unbecoming of a Govt. servant, thereby, violating the provisions of Rule 3 of CCS (Conduct) Rules, 1964.

ARTICLE-II

That the said Dr.Soma Gupta, while holding the aforesaid post during the aforesaid period committed grave misconduct in as much as she wilfully disobeyed the orders of the competent authority to report for duty, issued from time to time.

By the above acts of omission & commission, the aforesaid Dr. Soma Gupta, Lecturer/Assistant Professor exhibited lack of integrity and devotion to duty, which is unbecoming of a Govt. servant, thereby, violating the provisions of Rule 3 of CCS (Conduct) Rules, 1964.

And whereas, the charge sheet was sent to her at her last known residential address through post, but no reply /representation was received from her.

And whereas, the Inquiring Authority and Presenting Officer were appointed vide orders dated 25.01.2016 for conducting inquiry against the Charged Officer.

And whereas, the Inquiring Authority submitted an inquiry report dated 11.09.2017, holding the articles of charge as proved against the Charged Officer.

And whereas, a copy of the inquiry report was sent to the Charged Officer at her last known residential address vide memorandum dated 17.10.2017 for submitting her representation or submission on the same, if any, within 15 days.

And whereas, no representation was received from the Charged Officer on the findings of the Inquiring Authority.

And whereas, Hon'ble Lt. Governor, Delhi, being the Competent Disciplinary Authority, has considered the inquiry report, facts and record of the case. The Charged Officer, Dr. Soma Gupta, Lecturer /Assistant Professor, Delhi Technological University, has continued to remain unauthorizedly absent from duty since 02.08.2010. Prior to that, she had remained unauthorizedly absent from duty during the period w.e.f.13.01.2006 to 06.08.2006 and 20.12.2006 to 10.01.2010. She has not responded to any of the orders of the competent authority to report for duty, issued from time to time. Evidently, the Charged Officer is guilty of grave misconduct warranting exemplary punishment.

Therefore, Hon'ble Lt. Governor, Delhi, being Competent Disciplinary Authority, is of the considered view that the ends of justice would be met in this case against Charged Officer, Dr. Soma Gupta, Lecturer /Assistant Professor, Delhi Technological University by levying penalty of "*Dismissal from service, which shall ordinarily be a disqualification for future employment under the Government.*"

It is ordered accordingly.
